<p>The cost of attending college varies depending on the college selected, the number of credits enrolled, as well as other expenses such as room/board, books and supplies, transportation and other miscellaneous educational and living expenses. Financial aid programs, such as grants, scholarships and reciprocity programs exist to help students meet their cost of education. The North Dakota University System administers grants, scholarships and other incentive programs for students and graduates.</p> <p>What are some of the options?</p> <ul style="list-style-type: none"> ➤ GRANTS: Financial aid, often based on financial need, that does not need to be repaid. State and federal grants are available. ➤ SCHOLARSHIPS: Money awarded to students based on academic or other achievements to help pay for education expenses. Scholarships generally do not have to be repaid. Remember to research for private as well as institutional scholarship opportunities. ➤ LOANS: Money taken out on loan to pay for education and related expenses. Student loans must be repaid with interest. ➤ WORK: Federal and institutional work programs can help students earn money to pay for college. ➤ LOAN FORGIVENESS: Programs that provide graduates with student loan reduction if they meet qualifying criteria following program completion.

<p>North Dakota Indian Scholarship</p>	<p>Scholarship: does not have to be repaid</p>	<p>Complete an application annually with the North Dakota University System.</p> <p>Current year applications can be found on the NDUS website at http://www.ndus.edu/students/paying-for-college/grants-scholarships/#NDIS .</p>	<p>Applicants must be North Dakota residents and enrolled members of a federally recognized Indian tribe. Must be accepted for admission by a North Dakota institution of higher learning or state vocational education program.</p> <p>Scholarships are based on unmet need or merit. A minimum overall GPA of 2.00 is required.</p> <ul style="list-style-type: none"> • Students with a cumulative GPA of 2.0 - 3.499 must show unmet need to qualify. • Students with a cumulative GPA of 3.50 or higher can qualify based on merit. <p>An application is required annually.</p>	<p>Fulltime enrollment is required, which is generally defined as 12 credits per term undergraduate and 9 credits per term graduate.</p>	<p>Students can earn up to \$2,000 in scholarship funding per year for a maximum of 6 years.</p>

<p>North Dakota Scholars Program</p>	<p>Scholarship: does not have to be repaid</p>	<p>Take the ACT test as a junior in high school no later than July 1 preceding your senior year in high school.</p>	<p>This program provides premier merit-based, full-tuition scholarships to qualifying North Dakota high school graduates who choose to earn undergraduate degrees in North Dakota.</p> <p>High school students who score at or above the ninety-fifth percentile among those who took the ACT prior to July 1st in the calendar year preceding the individual's enrollment in college will be considered for the award. Students will be awarded in descending rank order until available funds are expended or until the pool of applicants has been exhausted.</p> <p>Stipends will be issued only if all qualifying students are first awarded a tuition scholarship.</p>	<p>Fulltime: defined as 12 credits per term minimum.</p>	<p>The amount of the scholarship is equal to the tuition rate charged at the scholar's institution, not to exceed the highest regular resident undergraduate tuition rate in the NDUS.</p> <p>Eligibility is limited to 8 semesters or 12 quarters of undergraduate study, or until the attainment of a baccalaureate degree, whichever occurs first.</p>
<p>Science, Technology, Engineering and Mathematics (STEM) Occupations Student Loan Program</p>	<p>Loan Forgiveness (following graduation)</p>	<p>Complete an application annually.</p> <p>The current year's application can be found on the NDUS website at http://www.ndus.edu/students/paying-for-college/grants-scholarships/#STEM .</p>	<p>The STEM Occupations Student Loan Program is intended to reduce loan indebtedness for college graduates who work in STEM-related fields in North Dakota.</p> <p>Recipients include graduates who successfully completed a board-approved STEM related program at an approved college and who earned a cumulative GPA of 2.5 or higher. Recipients must have been employed in a board-approved STEM occupation for 12 months in North Dakota following graduation.</p> <p>Income limits apply beginning with the 2018 application cycle. Watch for the 2018 application in spring 2018.</p>	<p>n/a</p>	<p>Awards made in accordance with statute.</p>
<p>Teacher Shortage Loan Forgiveness Program</p>	<p>Loan Forgiveness (following graduation)</p>	<p>Complete an application annually.</p> <p>The current year's application can be found on the NDUS website at http://www.ndus.edu/students/paying-for-college/grants-scholarships/#TSLPF .</p>	<p>This program reduces student loan indebtedness for individuals who hold a contract to teach at a grade level or in a content area and in a geographical location identified by the superintendent of public instruction as having an existing teacher shortage or critical need.</p> <p>Beginning with the 2018 application cycle, no more than two teachers per year in a school district may qualify for this loan forgiveness program. Watch for the 2018 application in spring 2018.</p>	<p>n/a</p>	<p>Awards made in accordance with statute.</p>

Professional Student Exchange Program (PSEP)	Scholarship: does not have to be repaid; no service requirement	Apply by October 15 of the year preceding entry into the professional program of study. Applications can be found on the NDUS website at http://www.ndus.edu/uploads/resources/3906/psep-application-2015.9.pdf	The Professional Student Exchange Program (PSEP) provides North Dakota resident students access to veterinary medicine, optometry and dentistry programs not offered in the state. Scholarships are dependent upon the contracts the state has with participating institutions. Awards are made based on student rankings. North Dakota has contracts through WICHE (veterinary medicine, dentistry and optometry, Kansas State University (veterinary medicine), Iowa State University (veterinary medicine) and the University of Minnesota (veterinary medicine and dentistry). Currently, North Dakota students who attend Minnesota campuses pay the Minnesota resident rate.		
	Midwest Student Exchange Program	Offered by the Midwest Higher Education Commission, the Midwest Student Exchange Program (MSEP) enables students to enroll in out-of-state colleges and universities at no more than 150 percent of the institutions' resident tuition rate. Each participating institution determines which degree programs it will make available to students, the number of students it will admit and its admission requirements. http://www.mhec.org/			
	Western Undergraduate Exchange	Through the Western Undergraduate Exchange (WUE) Program, students in 10 participating states may enroll in designated two-year and four-year institutions and programs in other participating states at reduced tuition rates. 	Western Regional Graduate Programs	The primary purpose of the Western Regional Graduate Program (WRGP) is to permit students from WICHE states to enroll in the more than 400 graduate programs offered by member states.
